The legal basis for the processing of personal data is Article 6. 1 e) RODO in connection with the Act of 20 July 2018 Law on Higher Education and Science (Journal of Laws, item 1668) and the university's mission to conduct scientific activities, shaping civic attitudes and participation in social development and creating an economy based on innovation. Your personal data will also be processed in connection with the legitimate interest pursued by the administrator, e.g. the investigation or defense of claims (Article 6. 1 f) RODO).
- 5. Your personal data may be made available to appropriate recipients, in particular: Participants of the event, as well as specific external entities involved in IT or legal service of the administrator and entities providing for the administrator other services based on contracts entrusting the processing of personal data. These entities will be obliged to keep confidentiality of the data being processed. Personal data may also be disclosed to institutions authorized to control the activity of the administrator, as well as entities authorized to access data on the basis of legal provisions.
